- · Stewardship-Managing resources wisely and ethically.
 - 3. Ethical conduct & Integrity
- 1) All individuals associated with Met By Love Ministries must:
- Conduct themselves in a manner that reflects Christ-like character.
- Act with honesty in all financial transactions, communications, and decision-making.
- Avoid conflicts of interest and disclose any personal or financial interests that may interfere with ministry responsibilities.
- Use ministry resources responsibly and for their intended purposes.
 - 4. Compliance with Laws & Ministry Policies

Met By Love Ministries operates in compliance with all applicable laws, regulations, and taxexempt requirements.

Representatives must:

Follow local, state, and federal laws affecting the ministry.

- Comply with financial and operational policies set by the board of directors.
- Uphold the ministry's internal controls and reporting requirements.

- Ministry records, donor information, and sensitive discussions must be kept confidential.
- Personal data and private conversations should be respected and not shared without appropriate authorization.
 - 6. Harassment & Discrimination

Met By Love Ministries is committed to maintaining a respectful environment.

- No form of harassment, discrimination or abuse will be tolerated.
- All individuals should be treated with kindness and respect
 - 7. Financial Accountability & Stewardship
- Ministry funds must be managed with integrity and used for their intended purposes.
- All financial records must be accurate,, transparent, and in compliance with auditing standards.
- Fraud, misuse of funds, or unethical financial behavior is strictly prohibited.
 - 8. Reporting Violations (whistleblower Policy)
- Individuals who suspect a violation of this Code of Ethics should report it in good faith to their supervisor, the CEO, or the Board of Directors.
- · Reports will be kept confidential to the extent possible and investigated appropriately.
- Retaliation against anyone who reports a concern in good faith is strictly prohibited.
 - Enforcement &b Disciplinary Action
- Violations of this Code of Ethics may result in disciplinary action, including termination of employment, removal from leadership roles, or legal consequences if applicable.
